cancellation proceeding before the Trademark Trial and Appeal Board; obtained favorable settlement, including client's broad freedom to operate under concurrent use agreement.

**Confidential Settlement in TTAB Proceeding.** Prosecuted likelihood-of-confusion claims in a trademark registration cancellation proceeding before the Trademark Trial and Appeal Board; obtained favorable settlement, including the assignment of the registrant's entire interest in the disputed mark to the client.

City of Sumner Building Code Issues. Defended owner of multi-building apartment complex in building code dispute against the City of Sumner involving constitutional issues of government exactions; obtained favorable settlement and dismissal of all alleged violations.
